Contract between Gregath Publishing Company, Incorporated (hereinafter referred to as "Gregath") and _____ (hereinafter referred to as "author/copyright holder"), in regard to _____ (hereinafter referred to as "book").

1. The author/copyright holder grants to Gregath the right to produce in printed and/or electronic form, advertise and market copies of the book worldwide and only in their entirety;
2. The author/copyright holder shall supply Gregath with a production manuscript of the book with photos (if any) which Gregath shall retain and use as a reproduction master and which shall become the sole property of Gregath. Actual photographs will be returned to the author/copyright holder after Gregath has made copies and are not considered part of the master;
3. Gregath shall pay the author/copyright holder the predetermined amount of \$ _____ per sold copy which shall be paid either (select one) by mail once the author/copyright holder's account reaches \$25.00 OR within 48 hours of fulfilled order by PayPal;
4. The author/copyright holder (select one) does not does approve production of book above paid orders in a quantity not to exceed _____;
5. Gregath shall abide by this contract, and make all additional production/marketing decisions as well as handling the complete ordering fulfillment processes, not outlined here or in the author/copyright holder's program application;
6. The author/copyright holder, estate, or successors shall be solely responsible for contacting Gregath in the event of a change of contacts (email, address, etc.) or Copyright holder (death, etc.).
7. This agreement constitutes the complete understanding of the parties. No modifications or waiver of any provision shall be valid unless in writing and signed by both parties;
8. The author/copyright holder represents and warrants as follows:
 - a) being owner of the rights of the book and has full power to enter into this agreement;
 - b) the book does not violate or infringe upon any rights of others, including personal or property rights of others
 - c) the book does not infringe upon any copyright, whether common law or statutory and
 - d) the book contains nothing libelous or otherwise contrary to law;
9. This agreement shall be binding on the successors and assigns of the parties;
10. The author/copyright holder or successors shall indemnify and hold harmless Gregath from any and all loss, damage, liability or expense arising from any breach of foregoing representations and warranties. The terms of this paragraph shall survive termination of contract and
11. This agreement may be terminated by either party upon ninety (90) days with written notice to the other. Any inventory at termination shall be liquefied as per article #3, until depleted.
